Instructions for Authors -ICDA 2020

We invite the authors to submit their abstracts to the ICDA-2020. Authors wish to present their research work at the ICDA-2020 should submit an abstract along with an extended abstract. The extended abstracts are solely for refereeing purpose and accepted abstracts will be published in the conference proceedings.

Guidelines for abstracts

- Title of the abstract (Font; 14, bold, Times New Roman) should be brief and explain the study reported. Capital letters should be used only for the first word of the title and proper nouns.
- The names and affiliations of all authors and the institutional address should appear below the title. Leave a single space between the title and the author names. Leave no space between the author name(s) and the affiliations. Font; 12, Times New Roman.
- Identify the corresponding author by an asterisk (*). The e-mail address of the corresponding author should be indicated below the institutional address of the author(s)
- Abstracts should consist of 250-300 words
- Three to five keywords or phrases in alphabetical order, separated by commas.
- No references, tables or figures should be included in the abstract.
- Language: UK English only

- Non-English terms: All non-English terms should be italicized. E.g. *et al.*, *viz*, *etc*, *in vivo*, *Yala*, *Maha*. All scientific names should be italicized. Both genus and species names should be mentioned at the first appearance and only the species name can be mentioned with abbreviated genus name subsequently. e.g. *Clostridium botulinum* and subsequently *C. botulinum*.
- Software: Microsoft Word (doc. and docx.)
- Page setting format
 - Paper size: A4 (210 x 297 mm) typed single side only.
 - Font: Times New Roman
 - Font size: 12
 - Line spacing: 1.5
 - Text alignment: Justify Margins: 2.5cm (1”) on all sides
- Abstracts will be reviewed by panel of experts, and those accepted will be published in conference proceedings.
- Authors of the accepted abstracts have the option to submit their full papers to the faculty journal titled “Journal of Dry Zone Agriculture” for the upcoming issue.

Note: Camera ready format will be send to accepted papers to prepare camera ready copy

Guidelines for extended abstracts

The extended abstract should not exceed 1500 words. Given below is the general outline.

- Introduction: Maximum of 350 words
- Materials and Methods: Maximum of 350 words
- Results, Discussions & Conclusions: Maximum of 800 words
- References: Maximum of 5 key references could be included [References should be given in ‘Harvard format’]

Introduction

- Author(s) should present the nature of the problem addressed by the study and position the work in the broader context of the field of study. Background material important for understanding the nature and impact of the study should be presented and appropriately referenced.

Materials and Methods

- This section should include the experimental materials, sampling procedures, experimental methods, experimental design and number of replicates and statistical methods adopted. Standard protocols should not be described in detail.

Results, Discussion, Conclusion and Recommendations

- This section should include the results of the experiments and extensive interpretation of the results. Present the results as concisely as possible. The findings should be discussed in relation to previously published work where appropriate and to the experimental system at hand and should not contain extensive repetition of the results or reiteration of the introduction. If it is relevant, conclusions and recommendations can be given. Use minimum number of Table and Figures in this section within the limitation of two A4 pages.
- **Tables** should be positioned in the relevant place in the text and prepared using MS word “Table format”. Do not use “tabs” or any graphics software to create tables.
- **Figures** should be positioned in the text and should be of high quality. Digital versions of Figures, preferably in JPEG or TIFF format should be sent separately. Figures should be presented with appropriate SD or SE values 3

- Authors should submit the electronic version of their abstracts and extended abstracts to the following e mail address: icda@univ.jfn.ac.lk. Please indicate the subject of the email as **ICDA-2020 abstract**.
- An Author Declaration Form giving the information on corresponding author and coauthors (if any) and preferred theme for submission should also be e-mailed as an attachment along with the abstract.
- An acknowledgement will be sent to the corresponding author by e-mail (or by regular mail, if necessary) once the extended abstract and author declaration forms are received by the ICDA-2020 secretariat. **Papers submitted without author declaration form will not be considered.**
- Authors who prefer to submit hard copies of the abstract and author declaration form, can submit 4 hard copies of the abstracts along with a soft copy of the abstract written in CD to the following address:
